

EXECUTIVE SUMMARY

In the challenging and unprecedented situation that was determined by the Covid-19 outbreak at the beginning of 2020, **Aqua Publica Europea** proved to be a vibrant community. Thanks to the commitment and dedication of its members, our network was able to promptly organise an intense exchange of information and experiences that, we are confident, helped each operator to fine-tune its response to the emergency.

In addition to facilitating exchanges among members, **Aqua Publica Europea** also worked on the "communication front": a series of communication campaigns were lunched to give visibility to the commitment of the public operators and their staff to ensure continuity of water services despite all the difficulties and uncertainties created by the lockdown.

It is therefore a source of great satisfaction the fact that the results of our joint work were then employed and praised by important institutions and stakeholders, including the Executive Director of UN-Habitat and renowned academics working on public services.

If the response to COVID's emergency absorbed a significant part of our efforts in 2020, **Aqua Publica Europea's** activity was certainly not limited to that. With regard to EU policies, the organisation of a seminar together with the European Commission on the joint implementation of the Water Framework Directive and Wastewater Treatment Directive was an important

opportunity to provide a contribution to the debate about the revision of these two key pieces of legislation. Drawing on the concrete experience of **APE's** members, we showed the importance of increasing the coherence of the policy framework at the EU level, if efficient and fair management of water resources is to be achieved.

This seminar offered a solid basis for a sustained engagement with the European Commission on their revision of the Urban Waste Water Treatment Directive that continued in 2021. But our advocacy action touched upon also many other subjects at the European and international level, including sludge management, taxonomy, development cooperation with developing countries, the impact of common agriculture policy on water resources, and many others.

Last but not least, at the end of 2020, Bernard Van Nuffel (President of Vivaqua, Belgium) was appointed as the new President of **APE**, thus replacing Ms Célia Blauel who, after accompanying for 6 years the growth of our association and the consolidation of Eau de Paris, took up new responsibilities. The appointment of Mr Van Nuffel was also the occasion to launch the revision of **APE's** strategy, in light of the profound cultural and political changes that occurred in the last 5 years. This revision will be concluded in 2021.



Managing the Unexpected aims to give an account of experiences and lessons learnt during the first months of the health crisis with the hope that, as the UN-Habitat Executive Director Maimunah Mohd Sharif states in her preface, "by sharing what has been tried and tested, these cases can contribute to the ongoing learning and support operators to help them respond to their specific situations".

Building on a series of virtual meetings and dialogues organised by **Aqua Publica Europea** during the first months of 2020, the publication is therefore the result of concrete collaboration and solidarity in the public sector at the European level.

 Dedicated to discussing the measures adopted by water operators in view of the recovery phase.



VIDEO-CONFERENCE 03 SEPTEMBER 2020


On 3 September 2020, more than 60 **Aqua Publica Europea's** delegates participated in the online General Meeting. The meeting was chaired for the last time by Ms Célia Baluel, who subsequently stepped down as President of **APE** and of Eau de Paris. Vice-President Mr Paolo Romano (SMAT, Italy) took over as acting President

Despite the limitations of the online format, delegates had the opportunity to interact and express their views on a range of topics from the mission of public water operators to priorities on the circular economy.

In this context, new thematic priorities for future work were discussed and adopted:

- water: a public service
- a blue-green horizon
- water operator: a sensitive societal actor.

These three lines of work reflect the crucial challenges and strategic objectives that water operators and Aqua Publica must address in the coming years.



In addition, to express gratitude to Ms Blauel for her fundamental contribution to the development of the association over the last 6 years, the General Meeting was also the occasion to welcome two new members Como Acqua (Italy) and the Catalan Association of municipalities for public water management (Spain).

The General Meeting was followed by an interactive session on Water Erasmus with the special participation of the European Commission.

NEW PRESIDENT APPOINTED

MR BERNARD VAN NUFFEL

In November 2020 the Board of Directors of Aqua Publica Europea appointed Mr Bernard Van Nuffel, President of VIVAQUA (Brussels' water operator), as the new Chairman of the Association and confirmed Mr Romano (SMAT, Italy) as Vice-President.

After studying architecture, Mr Van Nuffel began his career as a civil servant in Brussels' administration in 1997. Subsequently, he was elected Deputy-Mayor in charge of infrastructures, water policy and climate of one of the municipalities of the Brussels Region in 2018, and then appointed President of VIVAQUA in 2019.

In his acceptance speech, Mr Van Nuffel highlighted four priorities for the public water sector in Europe:


COMO ACQUA

Como Acqua Srl was established in April 2014, after the Province of Como and 49 Municipalities of the Province took over the water service management. Today, Como Acqua provided water services to 516.000 people.

The Catalan Association of municipalities for public water management, SPAIN



The Catalan Association of municipalities for public water management - AMAP was established in 2018. AMAP represents 39 main Catalan municipalities and public water operators, such as Aqua Publica's member the Barcelona Cicle de l'Aigua SA (BCASA), covering a total of 44% of the population in Catalonia. The association aims to ensure that water supply and sanitation services are guaranteed equally to all citizens, recognising water services as an essential and common good, which should serve public interests rather than corporate ones.





WORKING GROUPS

The Working Groups represent a fundamental pillar of the 'community dimension' of **Aqua Publica Europea.**

In March 2020, **APE's** Management Board approved the work programme for six Working Groups for the period 2020-2021 period, see here below!

The Working Groups activities in 2020 were impacted by the pandemic, but the coordinators ensured the interaction and collaboration among members through online video conferences. Furthermore, the annual programmes were adapted to take into account the new priorities following the COVID-19 emergency.



WG Financing and Economic Aspects



The WG Financing and Economic Aspects is coordinated by Cedric Prevedello (Aquawal, Belgium). Members have been exchanging good practices on the conditions for effective financing of water service and emphasising the contribution of public water services to socio-economic development.

 COVID-19 focus: Considering the outbreak of the COVID-19, the WG discussion have been focusing on the economic impact, recovery, and postemergency period.

The WG Performance is coordinated by Pedro Tomas Martin de la Vega (Promedio, Badajoz, Spain), Katarina Krcunovic (Eau de Paris, Paris, Spain) and Anita Papachristopulou (Eydap, Athens, Greece). The WG members have been exploring the conditions and characteristics of a 'well-performing public water operator' by collecting organisational charts and studying management approaches.

In 2020, APE launched the first annual call for interest to participate in the Water Erasmus initiative, with the aim to increase and systematise the realisation of staff exchanges among members.

While the COVID-19 outbreak reduced the possibilities to organise physical exchanges, Secretariat facilitated knowledge sharing through online thematic webinars and working groups mainly focused on COVID-19 challenges for utilities.

Water Erasmus facilitates cooperation between member utilities on topics of common interest through peer-to-peer exchange and knowledge sharing.


The "Opinion on the Fitness Check of the Water Framework Directive. Groundwater Directive. Environmental Quality Standards Directive and Floods" adopted on 2 July 2020 by the 'European Committee of the Regions', highlights Aqua Publica Europea's Water Erasmus initiative as a key tool to continuously strengthen water management.

A Water Erasmus session with the participation of Vasilis Liogkas (European Commission) took place after the 2020's General Meeting. Mr Liogkas illustrated the Technical Information Assistance and Exchange Instrument (TAIEX): a financing instrument that could support the Water Erasmus exchanges.

"Encourages national, regional and local authorities with publicly-owned water utilities to participate in the Water Erasmus initiative allowing technical staff to visit counterparts in the other Member States and learn from their water management practices. Exchanges of this kind, as well as other initiatives such as technical workshops, should be scaled up, as they provide an opportunity to raise awareness, foster dialogue, learn about solutions and build capacity'

EU FUNDED PROJECT

SMART.MET **WORKING TOGETHER ON** RESEARCH AND INNOVATION

The research and innovation project SMART MET, funded under Horizon 2020, moved to the next stage.

The SMART.MET, led by a group of 7 water utilities, all members of Aqua Publica Europea, aims to drive the development of new innovative solutions to deal with the collection and management of smart water metering data, through a joint pre-commercial procurement (PCP), under Italian law. Smart water metering presents itself as an effective solution to the challenges faced by most European water utilities today, from extreme events induced by climate change to the need to replace ageing infrastructure. Indeed, providing access to accurate data in real-time can help decrease operating costs and prioritize infrastructure investments, while also improving the daily management of networks and customer services.

SMART.MET intends to address the needs of water utilities regarding smart-metering such as the collection of accurate data in real-time, readability, interoperability and cost-efficiency, through a pre-commercial procurement (PCP).

This European research and innovation project was born integrally within Aqua Publica Europea, by a group of members aiming to find innovative solutions to challenges not yet addressed by existing products provided by the market.



In 2020, the consortium started the second phase of the joint Pre-Commercial Procurement (PCP). In this phase, the innovating companies that were selected through the joint PCP were invited to demonstrate the validity of their proposed smart water metering solutions prototypes in all their components: meter, communication infrastructure, and control systems. This phase will be followed by the final one, field-testing of the smart water meters (planned for 2021).

Aqua Publica Europea disseminated the project achievements through different communication channels and in public forums. In July 2020, Aqua Publica Europea was invited to introduce SMART MET in the online workshop on 'green companies for green regions and green cities' organised by the European Association of Development Agencies (EURADA).

















POLICY & ADVOCACY

Despite the external circumstances linked to the COVID-19 outbreak, the year 2020 particularly active in terms of policy files related to water and waste water treatment. From the wrap-up of new legislation on drinking water and water reuse, to the launch of fresh work on waste water treatment and sewage sludge, the regulatory framework has been changing deeply and operators must be prepared for the future. Furthermore, the crisis has highlighted the importance for health and society as a whole of not only water - through the continued supply of essential services - but also wastewater which can be a useful tool for surveillance of virus spread. While water continued to gain political momentum, Aqua Publica Europea's action focused on representing the perspectives and sharing the expertise of public water operators. key actors in the development of a fair, resilient. and sustainable society.

WATER POLICY

Drinking-Water Directive formally adopted

While EU institutions reached a deal on the "Drinking Water" Directive in December 2019, it took another year until it was formally adopted. **Aqua Publica Europea** welcomed the new transparency measures, improved access to water and a clear risk-based approach. The Directive will enter into force at the beginning of 2021, with a period of two years for transposition into national legislation. In the next years, several implementing and delegated acts are expected to complement the legislation, starting with an EU positive list of substances that can safely be used in materials in contact with water, to be established by 2024.

"With this new text, citizens will continue to enjoy clean and safe water no matter where they are in Europe. They will also have access to more information, thus fostering more confidence in tap water.

However, we believe more could have been done by the EU."



Water Reuse regulation adopted

The "Water Reuse Regulation", setting quality requirements for treated water to be reused for agricultural irrigation, was adopted by EU institutions amidst the Brussels lockdown in the spring and published on 25 May 2020. It will apply from 26 June 2023 throughout the EU. **Aqua Publica Europa** welcomed the objectives of the regulation and the distribution of responsibilities but also called for cautious use of water and raised concerns about the potential risks for ecological flows.

No revision of the Water Framework Directive but focus on implementation

Following the European Commission's evaluation of the "Water Framework" Directive in December 2019, the future of the legislation was in question until June when EU Commissioner for the Environment Virginijus Sinkevičius announced that there would be no revision of the text and instead instructed to focus on implementation and enforcement. Following up, the Committee of the Regions (CoR) adopted its Opinion on "Water Legislation" in July 2020 which, amongst others, acknowledged the potential of the Water Erasmus initiative to support implementation, and the European Parliament adopted a resolution on implementation of water policy" addressing key aspects for water management such as the precautionary approach to pollution and the polluter-pays principle, the protection of catchment areas and issues of water quantity and over-abstraction but also rejecting commodification of water.

Aqua Publica Europea contributed to discussions by sharing a Position Paper noting key elements to focus on in case the WFD were to be revised but also for its implementation and providing oral and written inputs during consultations.

In parallel to this work, the European Commission convened, in March, its new ad-hoc "Task Group on Economics" as part of the Common Implementation Strategy of the "Water Framework" Directive to discuss the economic aspects of the Directive.

Start of the revision process of the Urban Waste Water Treatment **Directive**

After publishing its evaluation of the "Urban Waste Water Treatment" Directive in 2019, the European Commission took up addressing the identified shortcomings by launching the review process of the Directive to identify and analyse policy options and aim to table a legislative proposal at the beginning of 2022. The process will include a wide range of consultations to address shortcomings including shortcomings of the Directive on overflow, small agglomerations, individual systems, nutrient levels and sensitive areas, the assessment will also look into new challenges including emerging pollutants, energy efficiency, emissions and sludge management.

In this process, Aqua Publica is actively contributing to public and targeted consultations and highlighting our members' priorities, notably prioritisation pollution control at the source; ensuring adequate funding and adopting a pragmatic approach to new requirements for circular economy and energy efficiency.




HIGHLIGHT

Aqua Publica Europea Technical Meeting -The combined implementation of EU water policy, March 2020

On 3 March 2020, **Aqua Publica Europea** organised a technical meeting between its Management Board, the *European Commission* and key water stakeholders, in Brussels, to discuss the concrete application of water policy, addressing, in particular, the question of the combined implementation of the "Water Framework" Directive and the "Urban Waste Water Treatment" Directive.

Taking into account the complementarity of the WFD and the UWWTD, the presentations of concrete experiences of public water operators' members of Aqua Publica Europea allowed participants to review their articulation and to identify the challenges in their combined implementation. From: Alsace-Moselle Report (France) sharing insight from the provisions of service in river basins characterised by several tributaries with varying levels of quality converging into one mainstream; Badajoz (Spain) in charge of the waste water treatment of small agglomerations in rural areas; Turin (Italy) focused on stormwater management in an urban context and Geneva (Switzerland) as Switzerland is deploying quaternary treatment for micropollutants.







ENVIRONMENT POLICY

Pharmaceutical in the Environment

In September, the European Parliament adopted its motion for a resolution on "a strategic approach to pharmaceuticals in the environment", as a response to the European Commission strategy presented in 2019. Members of the European Parliament called for effective measures to tackle pharmaceutical pollution and included a call for a revision of the "Sewage Sludge" Directive by the end of 2021. Aqua Publica Europea shared with policymakers the views that a life-cycle approach needs to be adopted to tackle pollution – as per the recommendation of the OECD - rather than focus only on the last-resort end of pipe solutions, in particular in order to facilitate the circular economy. We also noted the need to be careful not to place the burden of de-pollution on households and citizens rather than polluters, and to protect water affordability.

Zero Pollution Action Plan

In October, following the publication of the *European Commission's* "Roadmap on the EU Action Plan Towards a Zero Pollution Ambition for air, water and soil", as part of the "EU Green Deal", **APE** provided comments on the plans to tackle pollution. We called for the full implementation of the "Water Framework" Directive but also insisted that preventing pollution is the most effective and cost-effective approach, the polluter-pays principle needs to be applied fully and Extended Producer Responsibility schemes established, geographical differences between regions and contextual local characteristics should also be kept in mind.

CIRCULAR ECONOMY

New circular economy action plan and the start of the Review of the EU Sludge Directive

In the summer, the **European Commission** launched a study to review the "Sewage Sludge" Directive and analyse whether it is still fit for its purpose in the face of new challenges, including new pollutants and potential in a circular economy, with the objective to finalise the study by the end of 2021. With the support of the **APE's** working group on sludge and circular economy, **Aqua Publica** contributed to public and targeted consultations, highlighting the importance of having a stable environment and enable conditions that allow reaping the benefits offered by sludge reuse in a fair circular economy.



WATER & AGRICULTURE

In May, the *European Commission* published the "Farm-to-Fork strategy", as part of the "EU Green Deal" aiming to foster more sustainable food systems addressing environmental, health and food security considerations and setting targets by 2030: 50% reduction of pesticide use and risk and 25% of organic farming. Ahead of the publication, **APE** submitted a set of ten proposals to the *European Commission* for consideration, including for the protection of water resources and in particular catchment areas for drinking water from pollution. The strategy will be implemented through different legislative and non-legislative initiatives.





In addition, APE was consulted by the *European Court of Auditors* (ECA) in February on the pressure of agriculture on water quantity, including obstacles to the implementation of the WFD, the integration of water objectives in agriculture policy and funding. The report is expected in September 2021.



COVID-19

European Commission launches call to study the detection of the coronavirus in waste water

The European Commission's Joint Research Centre and Directorate-General for the Environment launched an EU feasibility assessment on the monitoring of SARS-CoV-2 in waste water as an instrument for early warning of infection in populations and a tool for health-related decision-making. **APE** was invited to cooperate with the European Commission and other stakeholders in the framework and facilitated the participation of individual members in the exercise and shared members' activities during an international knowledge-sharing meeting.





Post-COVID-19 recovery: The role of public water services for a more resilient, fairer and greener EU

Following the first wave of COVID-19 which deeply affected citizens' lives, economies, and public systems throughout the EU, and in the context of the adoption of the "EU recovery plan", **Aqua Publica Europea** published, during the summer, a policy paper to focus on drawing the lessons from the emergency and its management, to make the EU more resilient, fairer and more respectful of resources. We outlined the role of public water services in emergencies - and beyond - as essential services that leave no one behind; economic actors that can contribute to 'building back better and in the context of a greener future.

ECONOMY

EU Taxonomy

The "EU Regulation on the establishment of a framework to facilitate sustainable investment" ('EU Taxonomy') was adopted in June. This regulation provides a classification of economic activities for which investments are considered environmentally sustainable if they contribute to one of six environmental objectives (1) climate change mitigation; (2) climate change adaptation; (3) the sustainable use and protection of water and marine resources; (4) the transition to a circular economy; (5) pollution prevention and control; (6) the protection and restoration of biodiversity and ecosystems - without causing significant harm to any of the other ones. As a follow-up, the European Commission tabled, at the end of the year, a first delegated regulation on screening criteria (the actual parameters to assess if the investment is sustainable) for the first two objectives, including chapters on water and waste water activities. Aqua Publica Europea engaged with the European Commission to share the perspectives and challenges of the public water sector, highlighting the risk of impeding investments in a sector that not only has immense investment needs - as highlighted by the OECD - but also fundamentally contributes to improving the environment. The dossier will be picked up again in 2021.







BEYOND EUROPE

In this unprecedented year, Aqua Publica **Europea** joined forces with international organisations and stakeholders to promote equal access to water and sanitation across the world.

Aqua Publica facilitated several initiatives to share members' best practices and lessons learnt from the pandemic with utilities operating in third countries. Furthermore, the association endorsed an international initiative calling on European Institutions to give full support to water services in developing countries, as a key condition to fight the spread of the COVID-19 pandemic worldwide.

What's 2020, the European more. in Commission's Directorate-General International Partnerships officially confirmed the new funding programme to support the international "Water Operators' Partnership" (WOP), which will be managed by the UN's-Global Water Operator Partnership Alliance (GWOPA). Aqua Publica is one of the leading organisations that worked hard to make the programme a reality through a years-long advocacy initiative. Next year, the members of

Agua Publica will have the opportunity to apply for funding support under the new programme. and thus increasing their engagement in peerto-peer international cooperation projects to improve water management.






Public Water and COVID-19: Dark Clouds and Silver Linings (2020)

2021 OUTLOOK

The COVID-19 pandemic has certainly continued to affect the operations of **Aqua Publica** also in 2021. However, the persisting

restrictions to travelling and meeting have not prevented us from carrying out a farreaching programme of activities.

INSTITUTIONAL ENGAGEMENT AND VISIBILITY

- In line with the three new thematic priorities adopted by the Management Board, Aqua Publica organised in cooperation with Aguas de Gaia (public water operator from the city of Gaia, Portugal) a high-level conference on 'A Blue New Deal'. The event, which was supported by the Portuguese Presidency of the EU, was the opportunity to discuss the link between effective resources management and local development together with high-level speakers. including the Portuguese Minister for Environment representatives from the European Commission, European Committee of the Regions, NGOs, and water regulators.
- Pursuing the objective of strengthening the relations with civil society's organisations, Bernard Van Nuffel participated on behalf of APE in a seminar on Nature-Based Solutions organised by WWF in the framework of the Stockholm International Water Week.
 - We published a series of web interviews with the new Special Rapporteur of the United Nation for the human right to water and sanitation, Prof Pedro Arrojo, to explore together the conditions to realise these rights worldwide and the contribution that the public sector can give to achieve this objective.









OUR PLATFORM: FACILITATING EXCHANGES AMONG MEMBERS

This year we have resumed our Water Erasmus exchanges (although only online for the time being). Three exchanges were organised on the following topics:

- Energy efficiency (Scottish Water, Budapest Waterworks, Hamburg Wasser, Acquedotto Pugliese).
- Energy production in waste water operations (Scottish Water, Budapest Waterworks, Hamburg Wasser, Acquedotto Pugliese).
- Nutrients Recovery (Budapest Waterworks, Hamburg Wasser, Acquedotto Pugliese, Flemish Environmental Agency, European Commission), which also received economic support by the European Commission

POLICY WORK WITH THE EU AND BEYOND

- with The Secretariat. the active involvement and support from members, working intensively been exchanging with the European Commission on the revision of the "Urban Wastewater Treatment Directive and Sludge" Directive. A meeting between the European Commission and APE's Management Board was organised to bring the contribution of our association into the debate.
- The Secretariat has been active also on other dossiers, including the Taxonomy for the Green Finance, Pharmaceutical in the Environment, EU initiative on Sars-Cov-2 in wastewater, Zero Pollution Action Plan and, last but not least, APE contributed to a report by the European Court of Auditors on the impact of "Common Agricultural Policy" on water resources.
- In 2021 we welcomed the launch of the new funding programme by the EU to support international cooperation between water operators for capacity the "EU WOP development: programme". The new fundina programme is the result of the long advocacy action by Aqua towards the European Commission and several members have already seen their proposals for international project cooperation approved.
- Aqua Publica contributed also to initiatives of international institutions beyond the EU, in particular:
 - We contributed to the work of the "Expert Group on Equitable Access Water and Sanitation" under the International Protocol for Water and Health, convened by the "United Nations Economic Commission for Europe
 - We continued our contribution to the work of the OECD's initiative on 'Water and Finance'.


